Status Update of St. Mary church Alma June 21, 2023

Historical Background

- 2015-2018 Many Parish Surveys completed on options for the assets for Nativity of the Lord
- May 2019 Bishop Hurley relegated St. Mary Church in Alma to secular but not unbecoming use
  - This would have allowed the parish to sell or repurpose the building for other use
  - Environmental Architectural appraisal completed by the Diocese
    - Appraisal only include fixing the obvious, not restoring and making it compliant to current building codes
- June 2019 Parishioners appealed this decision
- July 2019 Bishop Hurley suspended his decree and the parishioners appeals where suspended
  - In this letter Bishop Hurley noted reasons that the presence of a church in Alma was needed
  - Bishop Hurley commissioned Deacon Rick, the Pastoral Council and the Finance Council to study the various appraisal and develop a plan to present to Bishop Gruss

- Organic materials that would have trapped water and mold where removed from the church (carpet, pews, pealing plaster, song books, etc.)
  - In an attempt to see if the building would air out and what further water damage existed beyond the surface
- Appraisals were evaluated and further inspections and construction estimates completed
  - Estimates to not just fix, but make the existing St. Mary Church sustainable for many years were > \$5 million.
    - Very high level estimate
    - These estimates would not have accounted for unforeseen issue
- A very successful capital campaign could raise 5x annual giving
- Talked with several foundations and philanthropic organization to seek financial assistance to restore the building
  - All organization were encouraging the parish to restore the building, but none were able to assist with financial support

Tasks Completed


- Parishioner feedback in the last survey suggested to consider other options for a church in Alma, namely, a smaller Chapel
- Work began to investigate the possibility of a chapel in Alma
  - Worked with a reputable commercial contractor who offered high level design and estimates
  - The cost and option of a Chapel in Alma was considered as a viable option

## Why Presence of a church in Alma

- 2/3<sup>rd</sup> of parishioners call St. Mary their home
- School is sustainable and growing
- Campus Ministry (Welcoming the young adults as part of our parish community)
- Parishioners are asking for it
  - We were baptized there
  - We received our first communion there
  - We were married there
  - Many parishioners left NOTL parish to other parishes, church denominations, or just left
- Sunday Evening Mass
  - 3<sup>rd</sup> Mass on the weekend
  - Gratiot County does not have a Sunday evening Mass to support the needs of busy or alternative schedules
  - Sunday morning Mass would continue to be at Mount St. Joseph Church





St. Peter Gallicantu in Jerusalem – Inspiration for the Chapel Concept





# Potential Chapel Cost ~ \$3 million

- Demo of existing church
- Building ~ 3500 SqFt Chapel
- Architect Design
- Construction Management
- Contingency
- Work would be needed to reduce costs
  - Reuse of existing church furnishings
  - Repurposing church furnishings (e.g. Pews) from other area churches

#### Next steps

- Formal Architectural drawings
- 90% accurate cost estimate
- Capital Campaign
